DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Boone Homestead faces north east onto Maple Ave in Severna Park. The entrance, however, is off of Maple Lane, a less busy street.

It is a 19th century dwelling consisting of two parts: a frame, five-bay, two story main block and a two story wing abutting it on the south side. The wing may be the older section of the house. Both parts have low iron stone foundations and are covered with German siding, painted pale green. A two story kitchen wing forms an ell on the rear of the main block, and an enclosed shed roof porch extends across most of the west (rear) elevation.

The main block has a center hall plan while the wing is essentially one large room (16 x 24) on the first floor. From the enclosed porch one can see the exposed siding of both parts of the house. The wing is covered with wide, vertical, cedar boards, and it appears that battens were present at one time.

A one story entrance porch with a gable roof shelters the recessed entrance in the center bay, main block. It has side lights with panels beneath, and the door itself is six-paneled. The door in the center bay of the wing appears to be a replacement. It is surrounded by a triangular pediment and pilasters.

Windows on the main block have 6/6 light, double-hung sash. Those on the second story of the wing are small and squat, while those on the first story are slightly smaller than those on the main block.

Both sections have gable roofs with the ridges running north-south. The main block has inside end chimneys, and a plain box cornice encloses the eaves. The pitch of the roof on the wing is steeper, the eaves overhang with returns on the south gable end, and there is a plain fascia board.

Interior: The first floor of the wing is one large room, and a chamfered joist runs the length of it. The joist is supported by a post which is also chamfered and pegged. Stairs were once located on the south wall. There is no fireplace visible on the north wall, and the room was probably heated with a stove which connected with the chimney flue in the wall of the main house. A chimney projects into the south wall of the dining room, but that fireplace has been covered. The stairs in the main block, on the south side of the hall, are open string with decorated step ends and plain turned balusters; the top of the walnut newel post is outlined with paint.

He was born in Anne Arundel County in 1839. Molter, 207 Marlbrook Road, Severna Park, Md. 21146.</p> <p>The house has been altered a great deal in recent years and retains little of its original character.</p>
