DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A market was erected by the Maryland Historical Society in 1964 on the east side of Route 468 near Galesville.

"Here April, 1672, George Fox, founder of Quakerism, opened the first General Meeting of Friends in Maryland, marking the beginning of West River Yearly Meeting and its successor, Baltimore Yearly Meeting of Friends. Site of the West River Quaker Meeting House."

The cemetery consists of about an acre of ground, surrounded by a white picket fence and shaded by large trees. Many members of well known Maryland families are buried there. Dates on the stones span the years from circa 1820 to the present.

The exact location of the meeting house site is not known though the structure is believed to have been standing through the first quarter of the 19th century. Tenthouse Creek, just east of the site, is believed to have gotten its name from the temporary shelters erected during the times of the yearly meeting.
