DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

A small, 2-story, frame structure, the Owings residence, is located on a hill Southwest of the intersection of Muddy Creek Road and South River Club Road.

The house has a typical, double parlor, side hall plan with two exterior brick chimneys at its East end. The roof is wood shingle; the exterior walls are sheathed in wood shingle, painted red. The front (North) elevation has a dentilled cornice. There is no porch over the front door. The windows are 6/6 pane openings with shutters. The South elevation is the same except that there is no cornice and there is no transom light over the door.

A one-story, one room kitchen is attached to the West end of the house. It also has an exterior chimney, shingled roof and red painted shingle siding.

The house stands on 6 acres of ground consisting of a small pasture and a yard with several large trees.

Probably built in the mid 19th century, (the shingle siding and the cornice are believed to be later alterations), the house may be the same one marked on the 1860 and 1878 maps as belonging to Mrs. O'Hara and William H. Howard respectively.
