

One-story side-gabled frame house.
Three-bay facade with door in the right bay.
Two rooms down, two rooms up.
6/6 windows except for one rear 4/4 shed dormer.
Siding: particle-board clapboards. Roof: standing seam tin over wood shingles.

This house was built in two sections, either as two separate 1-room down/1-room up houses which were joined together, or as an original 1-room down/1-room up house which was later expanded.

The larger section, at the west end, has 2 bays with door to the right, and an enclosed turning stairway which hugs the inside of the NE corner and ascends along the east wall. A new cinderblock chimney, centered inside the east wall, has replaced the original brick one up as far as the roofline. Above the roof the top of the old brick chimney still stands. Hewn posts are visible along the interior east wall where some plaster and lathes have been removed. The facade window to left of door appears original with old wavy panes of glass.

The smaller east section of the house has one window-bay front and rear, and a door in the gable end.



This house is similar to one at Ivy Neck Farm (AA-225) which is 1/2 mile south by water from Contees Wharf. Ivy Neck Tenant House #A has an estimated construction date of 1840-70. The arrangement of its larger (east) section is almost identical to that of the larger west section in the Sellman Tenant House: 2-bay facade with door in the right bay, a turning enclosed stairway inside left front corner of house, the stair door closing at 3rd step up from floor, the steps rising along left wall toward chimney, rear-elevation door and window lined up with those of the facade, and room dimensions approximately square.

According to local opinion, this was two slave houses joined together on the Sellman Farm. Mr. Kirkpatrick-Howatt, current owner of The Sellman House (AA-147), believes this to be true, as does his tenant farmer, Samuel Asher (born c. 1910 at The neighboring Contee Farm, AA-146).

The tenant house appears to be on the 1860 Martenet Map (see accompanying xerox).

Mr. Asher is the current owner. He has stabilized the house and uses it for storage.
