A minor variety of the English Romantic Revival residential style, this residence is two stories in height, rectangular in plan, 25'x 38' with a projecting entrance bay at the left part of the front facade, a one story porch along the southeast end wall and a one bay rear entrance porch. Four bay shed dormers are appended to the gable roof, the ridge line of the roof perpendicular to the street. The entrance has a broken scroll pediment. The frame structure is now sheathed with asbestos siding.




