This large Homestead style residence has a cross gable roof, is two and one-half stories and is rectangular in plan, 25' x 35'. 44 Madison Place is three by three bays, with 1/1 windows set in flat casings with molded surrounds. The gable ends have molded rakes with returns and a shallow cornice with weathering to create a mock pediment form. A full width porch is three bays wide with square posts and fan lit spandrels. The frame on brick residence is now sheathed with asbestos shingles.




