The deeply overhanging roof has a paneled frieze into which the windows are framed-windows at the side walls are casements in the first and third bays, 1/1 at the fourth. The hipped roof extends over what was a porch, now infilled with a ribbon of five 1/1 windows and a screen door with full bay width flat transom and sidelights. Frame over concrete block, the structure retains its original clapboard siding. Rectangular in plan, 25' x 45'. There is a one story concrete block gable roof accessory structure at the rear, of no significance.






