A Four Square style frame residence, two and one-half stories high, two bays by three, 20 Munroe Court has a hipped roof with deep overhang and flat frieze, and a hipped dormer with paired casements. Windows are 6/1, paired at the second floor of the front facade, tripled at the first floor. The entrance has a flat transom. A full width one story front porch has engaged Tuscan columns without rail or balusters. Rectangular in plan, 22' x 40', there is a two story rectangular bay at the rear of the right side elevation.






