DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Cobb house is a rather small, 2 story, frame structure on a double parlor, sidehall plan. It was probably built in the second quarter of the 19th century.

The interior has been completely redone and the exterior siding has been covered with asbestos shingle.

The most interesting feature of the house now is an unusual brick pent , or closet, built between the massive exterior chimneys.

The Cobb house is shown on the 1878 County Map as belonging to William Black. It also appears on the 1860 map with the name Black.


