One of a pair of two and one-half story vernacular townhouses, 7 Dean Street has a gable roof with corbelled chimney, hipped dormer and excellent bracketed cornice. All windows, including the dormer sash, are 1/1, with flat casings and molded lintel caps, the trim repeated at the transom lit door. The three bay by two frame structure is shingled and has a full width one story shed roof porch supported on slender turned columns, with a molded hand rail and square balusters. The raised porch is served by a straight, wide run of wood stairs, with later wrought iron rails, and concrete stairs to the sidewalk, which is three feet below the grade of the lawn. A two story shed roof one bay deep rear ell is original. Rectangular in plan, the structure measures 17' x 50'.


