The gable roof fronts on the street, with a one story hipped roof porch running full width. Windows are 1/1 in molded architrave trim with lintel caps. The porch is divided into two unequal bays by square posts with rounded end fascias, and the wall surface below the hand rail is infilled. The frame on block structure is faced with stucco, probably the original treatment.




