Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

Willow Glen is located on the north side of Governor's Bridge Road approximately one half mile west of Maryland Route 424. The house faces southwest and is sited on the downside of a gently sloping hill facing the road. It is clearly visible from the road, which is about 250 feet away. Further down the slope and to the west of the house are several large barns and outbuildings.

Willow Glen is distinguished by its gambrel roofs with dormers in both levels of the roof of the larger section. The extended wing to the east is a story lower and has dormers in just the lower roof. The main body of the house was originally a three bay side-passage structure. The wing to the east adjoins the passage side. A shed roof porch extends across the first story of the main house. The roof has grey asbestos shingles. The siding is weatherboard which decreases in width towards the top. Much of the lower boarding has been replaced. The foundation is stuccoed brick.

In the main house the windows on the first and second levels are six-over-six with narrow muntins. The panes measure 16" x 11"; the sills are four inches square. The door has six molded panels, the small panels being in the center. Above the door is a single-light transom. The exposed ends of the windows and door jambs are rounded. There is no other trim.

There are three uniformly spaced shed dormers in the lower level of the gambrel roof. In the upper roof are two gable roof dormers located above the space between the windows below. The dormer rake boards are beveled and have a return. These windows are also six-over-six, but the panes are smaller.

The porch floor is tongue-and-groove laid over plywood. It rests on heavy sills which are lap joined below the pillars. The sills are set on brick piers. There are four square pillars supporting the roof. These have no base and plain square capitals with a narrow necking trim below. The porch roof appears to have a flat slope on top, but the underside curves and is composed of circular sawn slats.

The long wing appears to have been built in two sections: a kitchen which has three evenly spaced dormers and a short corridor section which joins the main house and the kitchen. The section immediately adjacent to the passage wall is an area with a six-over-six window having 12½" x 10½" panes. A little to the left and above is a similar window in a shed dormer. On the east side of this section of the wing is a chimney set slightly below the ridge of the front slope of the upper roof. The remaining section of this long wing has three evenly spaced windows with

three dormers directly above. There is an interior chimney at the gable end which is centered in the ridge. There is a plain shallow box cornice on the front and rear facades of the wing. However, the siding does not reflect different stages of construction. The gable end of the wing has one window set to the north (right) on the first floor. The second level has two evenly spaced windows, one to the right is set immediately above the first floor window.

The rear or south side of the wing has a panel door on the left with five horizontal panels. This is sheltered by a small shed roof porch. To the far right is one window. Above are four shed dormers. The three to the east are similar to those on the front; the one on the far right is smaller with four-over-four sash.

The wing is set flush to the house in front, but extends in only a little over one-half the depth of the main house. In the exposed area of the main house there is a six-over-six window close to the wing side and a small four-pane outswinging window to the right. A bulkhead cellar entrance is located in the right side of this facade.

The rear facade of the main house is similar to the front facade on the first and second floors. However, there are no dormers on the upper roof level. This section also has a full shed roof porch supported by four plain square posts. The ground slopes away below revealing three barred windows in the foundation of the house itself.

The western gable side of the house has no windows on the first floor. The second floor has one window close to the front of the house and one just left of the center, both are six-over-six. The gable area has a small fixed four-pane window in the center. At this location the two interior chimneys can best be observed. According to the present owner these replace earlier exterior chimneys. The chimney on the left is set lower down the slope of the roof than the one on the front slope. All four brick chimneys have corbeled tops.

The first floor of the main house is composed of a side-passage, double parlor plan with the stair passage extending the full depth of the house to the parlors to the west. The principal staircase of the house is set against the eastern wall of the main passage. It is open-string with simple scroll brackets on the stair ends. The stairs lead to an intermediate landing and complete the run with three steps in reverse direction. The base newel post is large with heavy turnings. The secondary posts are not as large or heavily turned. Each step has two round balusters with a turned area one third of the way up. The handrail is fully rounded. All are darkly stained.

Beneath the stairway, the cellar stairs have been removed and a modern bathroom installed. This has a five horizontal panel door. At the foot of the stairs is a six-panel door, with a three-light transom, which leads into the wing.

A double parlour is west of the passage. These rooms are separated by taller and wider versions of the six-panel doors. One of these doors locks to the upper casing with a slide having a white porcelain knob. The doors close with a mortised latch. All the other older doors in the house have large box locks and a variety of knobs. In the front parlor to the right of the passage door is a servants pull ring.

The trim on the first floor on the windows and the doors is plain and butted; the top boards are wider and come to a peak. The baseboards are plain and painted black. The floors are random-width pine.

The fireplace in each room has a plain black marble mantel shelf. The chimney breast is sheathed with narrow beaded paneling. The fireplace surrounds have plain but beveled board pilasters set on simple plinth blocks. The fascia is equally plain.

The second floor of the main section consists of a hall with the stairwell plus enclosed stairs to the attic, a small room above the front section of the first floor hall and two bedchambers above the parlors. The floors are of random-width pine boards. The walls are plaster, but the ceilings have been replaced. The doors are the same as the first floor interior six-panel doors. The doors are trimmed with a beaded board with a heavy outer moulding; the window trim is plain and butted. The baseboard has a quarter round moulding on top.

In the two bedchambers are fireplaces similar to those on the first floor except for wooden mantel shelves. The openings have been enclosed, but both appear very large. Each chimney has a thimble above the fireplace.

The stairs leading to the attic are enclosed with tongue-and-groove boards. The door to the stairs is board-and-batten. The rafters on the east side have been badly charred from a fire. Some of the rafters were pit sawn; however the roof boards and later brace boards were circular sawn. There is no ridge pole, and the rafters are joined with pinned mortise-and-tenon joints. Rose head nails are used in the rafters. The random-width floor boards are very wide, up to 18 inches. The area around the dormers has been framed with wide boards.

The dirt floor basement is set under only one-half of the rear of the main house. Its walls are laid in random-course common bond. The heavy sills are hand hewn. A heavy cross beam is set off center and extends from the front to the rear of the house. The pit sawn joists are set perpendicular to this beam under the stair passage and parallel to the beam under the two parlors. There is framing evidence of a cellar stair under the passage. The chimney has a thimble. The owner recalls this area being used for cooking. The entire basement had once been whitewashed, with the exception of the chimney.

The first floor of the wing has a hall along the north side from the main section to a kitchen on the east end. Opposite the hall on the west side are two rooms with a stairway between. All the doors are four-panel. The door to the main section and the three doors along the side of the hall have three light transoms. The doorways to the main section and to the dining room are recessed. The door to the stairway and second room are not. Instead they are joined together and are framed as one doorway. The trim around the windows and doors is plain and butted. All baseboards are also plain boards.

The dining room of the wing has a large fireplace in the east wall. It has a very tall mantel with a plain, wooden mantel shelf, fascia board and sides. There is a raised concrete hearth. The surround is brick with a flat arch supported with a metal lintel.

The enclosed stairway leading to the second floor is very crude, suggesting a very early construction. Around the stairwell on the second floor the balusters are square, and are set at a 45° angle. The newel posts are chamfered squares with diamond shaped tops. The handrail is also square and chamfered. Against the wall is one-half of a newel post.

The pantry along the south side is smaller. The room on the east end of the wing is used as a kitchen. On the east wall is an inside chimney with a thimble. On the north wall are kitchen cabinets. There is horizontal tongue-and-groove wainscoting on the walls. The floor in this room has narrow boards, whereas the other rooms have wider, random-width boards.

The second floor of the wing has a room at each end with the stair and hall between. A small room at the northeast end of the stairhall is now a bath. Upon entering the first room from the main section, there is a step down. On the east wall is a built-in small closet. This room has a narrow cornice board. The door to the main section is four paneled, but the one to the hall is board-and-batten. The trim around the doors is plain and butted. The dormers have a wooden outside trim with plaster around the openings.

In the hall the doorways to the bath and the east room have beaded trim. The trim on the board-and-batten door is plain. The dormers in the bath and hall are the same as in the first room, but the ones in the east end room have tongue-and-groove wainscoting around the opening. All the walls and ceilings on the second floor are plaster.

Observed above the ceiling in the wing is the original exterior siding of the west wall of the main house.

There are several buildings on the property to the north. One is an old tobacco barn. The side sills are put together by angled dovetails. The center top beam has wooden pegs. Logs are used as cross pieces to hold the rails.


