Frame with aluminum siding, the structure has a full width one story porch with turned Tuscan columns and turned balusters. All sash is 1/1 with flat casings. The deeply overhanging eaves of the roof break to surround a three part two story bay unit at the rear of the right end wall. Rectangular in plan, 30' x 40', with a one bay one story rear porch, this structure is part of a row of three identical buildings.
