DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>Standing on part of a tract of land once known as "Chaney's Purchase", the Vitzthum home has a prominent hill-top location near Davidsonville. On clear days one can see the Bay Bridge, 20 miles away. The view in all directions is of rolling countryside.</p> <p>The house is a mid-19th century frame structure in 3 telescoping parts. The exact dates of the building are not known. The largest section has two stories on a side-hall, double-parlor plan. The attic once had two dormers on each side. There is a dining room and pantry on the first floor of the middle section and there are two bedrooms above. The shallow roof-pitch of this section leaves no room for an attic. The kitchen is also 2 stories but with lower ceilings and simpler, more rustic, detailing. It is possibly older than the rest of the house.</p> <p>The interior has several interesting features. A heavy wooden water tank in the attic is still intact though the windmill has disappeared. There are three "Carpenter" locks to be found on the kitchen and attic doors. The stair has massive walnut posts with a shape reminiscent of Egyptian columns. The door and window moldings are unusually narrow with square corner pieces and carved medallions. There is one false mantel on the second floor identical to the wooden mantels found at "Tilden Lawn" (AA-30-N-a). The white marble mantels in the three main rooms on the first floor have arched openings and elaborate carving of oak-leaf or floral patterns. A huge mirror with a heavy wooden frame is hung above one of the mantels. The fact that the top of it is not visible indicates that the ceilings have been lowered from about 11 feet to 10 1/2 feet. The pantry is an unusual feature of this house. It has built in shelves and counter and a pie-safe with pierced-tin panels.</p> <p>The exterior has horizontal wood siding. The back porch extends across the largest section while the front porch covers both that and the middle section. The front porch has fluted columns and other classical details.</p> <p>A board and batten carriage house to the north of the kitchen has a pannelled tack room, stalls, and quarters above for a servant. It was probably built at about the same time as the house.</p> <p>The Vitzthum house appears on the 1860 and 1878 County Maps as owned by William G. Mackall.</p>
