2057 The Jacob Bird Tenant House is a modest 3-bay 2-story frame house, with two rooms each floor, facing east. The enclosed stairway hugs the interior south wall of the north room. An original chimney and 1st-floor fireplace (crudely constructed) are centered inside the south end gable wall. Fireplace has been closed with plasterboard. Original north gable wall and north chimney were removed, apparently after fire damage, and the house was extended northward about 6 ft. The original siding still exists under later wood shingles. By description of current owner, this original siding consists of plain boards (3"x1") laid horizontally with no overlapping. Underneath is a hewn heavy timber frame consisting of 8"x12" vertical posts at corners of original block and on either side of center-bay doors; posts extend foundation-to-attic with no break at second-floor level. Later north extension of house has sawn structural members. The original wood shingle roof, covered with tin, was carried off during two storms, c.1970 and 1976. The current tin roof is new. Full-width screened porch, east facade. Full-width 1-story shed addition, west elevation. House rests on piers. Crawl space underneath.

2057-A The J. Irving Bird, Jr. House, built 1914, is a 3-bay 2-story frame "four-square" with hipped roof and cross-hipped rear el. Standing seam tin roof, deep eaves. 2/2 windows, original. Full-width screened front porch. Painted brown wood shingles over orig. horizontal weatherboard. Shutters, first floor. House in rough shape, but substantially unaltered. Nice proportions.

The east elevation of "Larkins Hills"(AA-151) can be seen about a mile away across fields to the west, a view very little changed in 100 years.

The Jacob Bird Tenant House is identified on the 1878 Hopkins Map. (See accompanying zerox of map.) The map shows the house to be south of Mill Swamp Road, in the northern portion of Jacob W. Bird's 780-acre property, which his father acquired early in the 19th century from Richard Harwood. It is not clear how old the tenant house is, however a rosehead nail (pre-1815) was found during renovations of the house by the current owners, Mr./Mrs. Benjamin Dove. (They don't remember where in the house the nail was found.) Many more of these nails can be seen throughout the Mary's Mount house (AA-153) which is thought to be the original main house on this Harwood/Bird property.

According to Benj. Dove, Jacob Bird's son Joseph Irving Bird (1856-1931) divided the property between his sons J. Irving Bird, Jr. and Dr. Jacob Wheeler Bird. The former brother was given the northern portion including the Jacob Bird Tenant Hse. (and probably also including another "tenant house" 1/5 mile to the east, now owned by the Middletons who have substantially altered it. See contact photo in MHT negative-file under AA-2057-B). The division of property may have taken place in Oct. 1913 at the same time that a survey was prepared by E. Lacy Chinn (survey referred to in B. Dove's deed). The latter brother, Dr. Jacob W. Bird, was given the southern portion containing both the Mary's Mount house, where his father Jos. I. Bird had resided since at least 1878 (see 1878 map), and the house called Dryad Hill (burned c.1950 by Dr. Bird) (3/5 mile east of Mary's Mount).

According to Benj. Dove, in 1914 J. Irving Bird, Jr. built himself a new house on his northern portion, 1/4 mile west of the Jacob Bird Tenant Hse. He also built a small cow stable sheathed with horizontal weatherboards. He had a tenant farmer Mr. Harrison and his family living in the Jacob Bird T. Hse. The farmer's son Billy Harrison, born there in 1915, has visited Benj. Dove.

Joseph Irving Bird died in 1931. The same year, J. Irving Bird, Jr. sold his share of the property to Louis Hamilton Moreland (FSR 87/259). The Doves bought the property from the Morelands in 1943. Benjamin Dove and his wife live in the Jacob Bird Tenant Hse. His brother Melvin Dove and wife live in the J. Irving Bird, Jr. House.
