Masque Farm is located within Annapolis City limits, on the south side of Masque Farm Road. The farm consists of 86.94 acres upon which stands a heavily modernized 19th century dwelling with 20th century addition. Outbuildings include a badly dilapidated chicken house, a ruinous tenant house and a 20th century grain silo. Most outbuildings were razed in the 1960s.

The farm house is large, containing approximately 3,500 sq. feet and features at least three episodes of construction. At the core is a mid-to-late 19th century I-house with two-story ell. Projecting from the west of the I-house is a 1932 two-story, addition that is now the building's front. The classically-inspired front façade is distinguished by its large, pedimented cross gable. Other embellishments include pilasters and a trabeated door surround. The symmetry of the four bay front façade is interrupted by an off-center front doorway.

The historic core of this building is obscured by a series of modern accretions. The attic yields little information as to the building's evolution as most joists and rafters are sheathed with plywood. The few exposed members of the building's core display circular saw marks and wire nails. This may indicate a total rebuild of the roof when the house was expanded in the 1930s. The house was originally sheathed with german siding, but the entire mass is now covered in vinyl siding. According to tradition, the foundation of the original building (now the kitchen) was built in 1859. This claim appears specious as the brick foundation under the kitchen looks contemporary with the majority of the house.

The house underwent extensive renovations in the fall of 1998 and retains very little historic material. Excepting some doors and a 1920s upstairs mantle, all original finish, including plaster walls, have been removed. Hardwood floors dating to the 1930s expansion and renovation remain. They were sanded and stained in 1998.

Reportedly Masque farm derives its name from an vernacular English phrase meaning "to hell with it". While the land associated with Masque Farm has been occupied since 1673, the current farm house was constructed in the late 19th century and expanded to its current configuration in 1937.

An unpublished history of the farm was written in 1984 and is located in the site files of the Historic Preservation Planning Section of Anne Arundel County Department of Planning and Code Enforcement. It suggests that the original farmhouse was erected about 1856, the year William Williams and Martha Murdoch were married. A house is shown in this location on Martenent's 1860 and Hopkin's 1878 atlas. Visible physical evidence does not support such an early date.

It is more likely that the I-house and ell portion was built by J.H. Vansant after his purchase of the property in 1889, or alternatively, after the property's purchase by Frederick Stehle in 1910. According to the unpublished history, Stehle made improvements to the house and farm. In 1913 he defaulted on the mortgage and the farm was purchased by his brother who allowed Frederick Stehle to remain on the farm as a tenant. Frederick Stehle subsequently purchased the farm back from his brother, but lost it again during the Great Depression.



The farm was purchased in 1937 by Admn. Robert "Ike" Giffen. Giffen expanded the house to its present configuration. Giffen, Director of Athletics and the U.S. Naval Academy, operated the farm recreationally and upon his retirement devoted his full attention to agriculture. In 1976 Giffen turned the property into a Christmas tree farm. The property is owned by Giffen's heirs who continue to operate the Christmas tree farm and use the house as an office for the family business.


