DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Dodon burned in Nov. of 1955. The house was frame, two-and-half stories high, and had four chimneys (exterior?). A one -and a-half story wing abuted it. The house was thought to have been built by George Stewart, c.1811, for his children. The house had been used as a monastery in the the late 19th century. Although there does not appear to have been any connection between the two tracts of land, one can not help but notice the similarity between Dodown and her neighbor Rowdown (AA_0207)
