DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Jones' house was falling into ruin when they bought it in the late 1960's. The restoration is now almost complete. It is ^{not} known when the house was built. There is record of a change of ownership-made in 1825 when Isaac Jones (an ancestor of the present owner) acquired the property and the house from Anne Plummer. It is shown on the 1860 and 1878 maps of the county as owned by Edward Jones. The property went out of the family in the 1900's. It was owned by William Shepherd until his death in 1965. The proportions of the house, with its low, steep, roof-line, are indicative of an eighteenth century structure. So much of the interior and exterior detailing has been changed over the years that it is difficult to determine its age.

A new wing was added to the east end of the house during restoration. The two chimneys on the west end have massive bases. All but the framing of the west wing was replaced by the present owners. The moldings in the main block of the house are square-corned with medallions.
