## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Taylor residence is a typical, mid-19th century house. It is of frame construction two-storied high with a double parlor, side hall plan. The exterior is sheathed in plain, board siding. A one-story porch extends across the front. The house faces east. There are two exterior brick chimneys at the north end and a smaller kitchen wing extends from the rear (west) elevation. The kitchen wing is one-and-a-half stories with an exterior end chimney. The main part of the house is unoccupied and is falling into disrepair. The surveyor was not permitted to photograph the house.

Worthy of note is an unusually large white oak tree standing to the south of the house on the entrance drive.

The 1860 Martenet map of the county shows that the house belonged to JP Drury the 1878 Hopkins map shows that it belonged to Samuel Drury.
