Based on available information this bungalow located at Severn/Danza Park in Anne Arundel County, Maryland, is not located within the boundaries of a state listed historic district and does not meet the criteria for individual listing on the Maryland Register. This simple, two story, frame cottage lacks the architectural distinction to qualify for listing under Criterion C. This structure, dating from the first quarter of the 20th c., has been remodeled repeatedly and retains little of its original character. The property is not known to have any associations with persons or events significant to our past, and thus does not qualify under Criteria A or B.
