Based on information provided by Anne Arundel County and previous reviews of barracks in this group, we have determined that Building #2031 does not meet the criteria for individual listing in the National Register of Historic Places nor is eligible as a contributing resource in an historic district. Building #2031 was constructed as a temporary barracks during the early 1940s. It was one of thousands of barracks built across the country for the World War II mobilization. Many of these buildings were built to a standardized plan. This building does not appear to be particularly significant for its associations or architecture. Although the exterior is essentially unaltered, the interior has been substantially altered. Building #2031 does not appear to be located in an historic district. When constructed, it was located in a block of over 12 identical buildings. The other five buildings in the row with Building #2031 along 20th 1/2 Street have been substantially altered on both the exterior and interior for reuse as a facility for the homeless. Many other buildings in the block have been demolished. Thus the block of barracks lacks integrity. In addition this block of buildings is located across Route 175 from the rest of Fort Meade and is far from the small section of brick, administrative buildings which is considered most likely to be eligible for the National Register. We have previously determined other barracks buildings in the block to be ineligible for the National Register based on lack of integrity.




