DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

"White Oak" is a large, 2 1/2 story, frame house, with an A-roof over a side-hall, double-parlor plan.

The present owners began restoring the house in 1970. The exterior is sheathed in horizontal siding of Georgia pine in graduated widths. On the east end, chimney, wall it has been covered with asbestos shingle. The chimneys have been relined. Marks on the brick show that there was once a low pent closet between them. The owners have a photograph, taken in 1900, which shows the house with a one story detached kitchen. A low hypen enclosed the passage to the house. The present kitchen, attached directly to the house, was built in 1910.

The interior of "White Oak" is in excellent condition. The stair, with 6" risers, is open to the third floor. Panelling under the stair is made of narrow vertical, tongue and groove covering much earlier wide panelling. The floors in the house are original. There are five original doors with #60 Carpenter locks.

The owners believe that the house was built before 1780. It is more likely to be an early 19th century house. Some changes were made in about 1880: the front door was replaced and a new porch built over the entrance. The present owners left the beams exposed in the dining room after replacing the plaster.

STATEMENT OF SIGNIFICANCE

"White Oak" is a simple, but elegant house. It is located on a large working farm in open country side. From the top floor windows it is said that one can see the Patuxent River, three other counties and Washington D.C.

The house appears on the 1860 and 1878 county maps as belonging to Jos. Arminger and W. Sunderland* respectively.

There are several other buildings on the farm which date from 1850 or before: a corncrib near the house and a large barn down the lane toward Pindell Road.

*presumably the same William Sunderland who was operating a cartmery at Bristol Landing in the 1870's.
