DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

A large, well-kept, frame house standing on a steep hill above the Mt. Zion Road, Mrs. Wayson's home was built in 1898 by her father, Joseph Sheperd. The house is a center hall type with chimneys backing the hall. The kitchen forms an ell in the rear of the house. The west wing was added in about 1908.

The interior has been altered somewhat. The kitchen chimney has been covered (a wood burning cook-stove was used originally). *Steam-heat* was added and other improvements made in the 1940's. The mantels in the parlor and dining room have delicately carved Ionic columns on the sides and a simple geometric pattern of vines and flowers on the transverse section. *They are of a nice design and in good condition.*

A tenant house to the north east of the main house is a telescope style in two sections. It was typical of the small houses built as quarters for slaves and dates from about 1850.
