DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This three part, telescoping, frame house stands at the end of a long lane at some distance from the paved road. The present owner grew up in the house but knows little about its history. It appears on the 1860 map of the county as owned by William H. Hopkins. The name J.T. Hopkins appears on the 1878 map. The house was probably built in the second quarter of the 19th century.

The main section has 2 1/2 storys with a 2 bay front. It is one room deep and has an exterior chimney. The middle section has 2 bays, 1 1/2 storys and an interior, end chimney placed slightly off-center with the roof ridge. The second floor windows are small and placed high under the eaves. The kitchen wing has one story. It is one room with a small loft above. The roof pitch of this section matches that of the main house. The pitch of the center section is less steep.

A narrow shed with a battened door is attached to the kitchen.
