DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

"Tamarack Hill" was built by William Peake shortly after his marriage in 1866. Peake planted several varieties of trees around his new house. Two tamaracks, one of which remains, gave the property its name.

The house is 2 1/2 story's under a hipped roof with a gable on each of the four sides. The plan is a double parlor with a side stair hall. A two story wing adjoins the rear parlor. A porch extends across the front of the house.

The house has been altered through the years - asbestos siding added, shutters removed. The mantels and fireplaces remain though the floors have been covered. The stair has a walnut bannister, with a heavy newel post. The open string is undecorated however the understair is enclosed with narrow verticals in simple scrollwork pattern.

The house is now occupied by a granddaughter of the builder.
