DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Spriggs Farmhouse is located on the east side of Bay-Berry Drive, off of Shore Acres Rd. Situated on a high mound-like hill, the house is ringed by a colorful garden with a lilac hedge in front of the entrance which faces south. To the north, the land slopes off abruptly to fields and the Magothy River.

The structure is a late 19th century, 2 story, 3 bay, frame house, covered with brown wood shingles. The main entrance is on the south elevation. A 2 story wing (added c. 1910) joins the rear of the house. Originally, the house contained four rooms- two down and two up.

A one story screen porch projects from the center bay, front elevation. Another porch with a shed roof supported by wooden poles extends beyond the east elevation to include a polygonal porch (built by the present owner) overlooking the Magothy River.

Most of the windows have 6/6 double hung sash. Double windows were added on the first floor, front elevation. In addition, a modern bay window was added to the first story, west elevation.

The house has a gable flank roof with wide eaves and a molded cornice. An inside end chimney is on the east gable end.

The interior has been completely renovated by the present owners.

STATEMENT OF SIGNIFICANCE

The Spriggs Farm House is a small two-story, brown, I-house, built c. 1890. The building itself is quite ordinary, but the setting is extraordinary. The hill top on which the house is located resembles a large mound. From it one looks north across the Magothy River to Little, Dobbins and Gibson Island. Archeological digs conducted by Professor Harry Story at the Sprigg's farm disclosed significant Indian activity there in the "Selby Bay Phase (500 A.D.)". The owner has added a polygonal porch to the north elevation which has a primitive appearance somehow appropriate to the structure.
