DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This simple frame farmhouse is marked on the 1878 county map with N.S. Cook and Ann Cook as the owners. N.S. Cook appears in the "List of Patrons" of the 1878 atlas. He was born in Anne Arundel County in 1856. He owned 108 acres and listed his occupation as farmer.

The house has two, 2 story, sections. The larger section is probably the older. It is five bays long and has an entrance in the center bay. The door is framed by a flat pediment and fluted pilasters. This may be a stock item applied sometime after the house was constructed. There is a single flue, interior chimney at each end of the moderately pitched A-roof. All of the windows are tall, 6/6 pane openings. The entire house is sheathed in German siding and both sections have metal roofs. The smaller section has no chimney.

The house was probably built in about 1850.
