DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This building is a good local example of adaptive re-use. It was originally constructed as a step-down transformer for the electric cars on the W.B.&A. railroad. Taken over in 1962 by the Ann Arrundell County Historical Society, it was converted to use as a museum, antique shop and headquarters.

The building is situated on a long, narrow strip of land between the Old Annapolis Boulevard and the tracks. The structure is brick. It has a plain box shape; approximately 21 feet high, 26 feet long and 12 feet wide. The roof is flat and has a low parapet, defined by several projecting brick courses at the top of the walls.

The east wall, facing Old Annapolis Boulevard, has three, evenly spaced, segmentally arched, window openings. They have 6/6 pane sashes and louvred shutters. The entrance to the building is placed under the northernmost of these windows.

The north wall has four circular ports or conduits placed near the top. These have been glassed in and they now light the stairway inside.

The interior of the building has been completely refinished. A partial second floor was added. It is about 2/3 of the length of space and it is reached by a set of steps at the north end of the space. A bathroom was installed under the steps. A linoleum tile was laid on the first floor and exhibit shelves were installed along the west wall. The south wall, which has no openings, was left with the natural color of brick. The rest of the walls inside and out were painted.

The society leases the building from the MTA.


