DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE	
<p>Situated near the Little Magothy River on Persimmon Point, this house appears on the 1860 and 1878 county maps as owned by William Stinchcomb. The farm land around the house was sold in about 1935 to a man who was interested in developing a community similar to Gibson Island for people from Washington. The project was never begun and the abandoned fields were beginning to grow over when another developer began, in the early 1950's, to sell the lots which now form Cape St. Claire. The house, a few small out buildings, and the graveyard have been retained in a separate parcel from the rest of the property.</p> <p>IN the graveyard are buried members of the Stinchcomb and Tydings families. According to the 1860 and 1878 county maps these people had their homes in separate locations along the south shore of the Magothy River.</p> <p>Henry Tydings (1826-1911) lived nearby at Goshen (#339 on survey). He married twice: 1. Margaret (1827-1873), 2. Eleanor (1838-1906)</p> <p>Alfred Asbury Stinchcomb (1848-1915) and his wife, Sarah Adams (1844-1932) farmed 176 acres in the area of Manhattan Beach. Their residence is marked on the 1878 map but could not be located.</p> <p>William (1820-1893) and Rosina (1829-1900) Stinchcomb probably occupied the house at Persimmon Point.</p> <p>The house has undergone considerable alteration in the last 25 years. In about 1950, the two part frame structure was sheathed in brick. The window sashes have been replaced and some of the openings enlarged or relocated. The interior has also been renovated.</p> <p>However, enough of the original fabric remains to give an indication of the early appearance of the house. The principal section is two stories high under an A-roof. It is one room deep, with a center hall, and interior, and chimneys. Attached to the east end of this section is the kitchen which consists of one room and a loft under the steeply pitched A-roof.</p> <p>The kitchen is probably the oldest part of the house. While the present owners were renovating they discovered that the wall between the kitchen and the principal section contained part of the exterior siding of the kitchen. The principal section of the house is believed to have been constructed in two stages: the east room and the hall built in about 1800. An early 20th century drawing shows the house with all three sections, sheathed in wood siding with a tin roof. The wood siding is still under the brick veneer.</p>

The interior of the principal section of the house has several interesting details. The floors appear to be the original random-width pine. The door moldings are simple: 4 inches wide, with mitered corners and a plain bead on the inner edges. The stair is narrow and steep. It is a straight run up to the second floor. It has a round hand-rail, square balusters, and unusual newel posts. The top and bottom ends of the handrail are curved outward in a semi-circle. The rail is supported on posts of the same semi circular shape. The posts are solid pieces of wood, 2 inches thick, concave on one side, convex on the other.

Two doors, one at the foot of the stair, and one at the back of the stair, lead into the east room (dining room). One door at the center of the passage leads into the west room. The west room and hall are decorated with wide plaster cornices and ceiling medallions, typical of those found in "fancy" houses of the 1840's and 1850's.

The second floor plan of the house consists of a hall, running along the north side and providing access to three bedrooms, one on the east side of the stair, two on the west side. The third floor (attic) has been finished into rooms. It is lit by gable end windows, and it is reached by a narrow enclosed stair.

The kitchen has been completely modernized. The original chimney is gone but the enclosed stair to the loft remains.

On the north side of the house are the field stone foundations of an ice-house. The rest of the early out buildings have disappeared.
