AA-405

Octagonal tower with belfry; simple molded cornice with dentils at projecting tower; upper level of tower with round windows at eight sides, tower enclosed by parapet with carved limestone balusters; second level has open three bay arcade with embossed limestone keys and balusters; lower level of tower is entrance bay with round arched opening enriched with a limestone archivolt and impost; entrance has fan lit double doors; main block has splayed brick arches at windows, timber sills, granite watertable.


RELATED STRUCTURES: (Describe)

STATEMENT OF SIGNIFICANCE:

Built in 1825 and altered 1892 and 1925, this facility was first constructed as a county courthouse, since the court met from 1694 through 1769 in the successive Statehouses. Important Federal first phase with well designed later additions and cupola/belfry. Important as a type and as an example of sensitive growth and alteration, and critical to the townscape of Church Circle.

4. NOTABLE FEATURES, HISTORICAL SIGNIFICANCE AND DESCRIPTION

OPEN TO PUBLIC  yes

An extremely handsome public building - of age and still being used for intended use. The Federal facade, 5 parts - main block, two wings, plus hyphens, is quite refined with practically no embellishments - merely two storeys with 7 bays of 12/12 windows. The wings are particularly nice with their triangular pediments and oeuil-de-beuf "window" (louvred ventilator). All windows with splayed brick lintels - those on wings have granite key stones. Subsequent additions have been made and a cupola and projecting porch have been added. The cupola may be attempted echo of state house dome, at any rate, it doesn't totally over power the federal facade (I think building was better looking without cupola). Fine example of public Federal (too little Federal in Annapolis).






