St. Anne's Episcopal Church rectory, now serving as part of the parish house complex, stands prominently on the south side of Duke of Gloucester Street between Church Circle and Charles Street. Dated to 1896-97, the two-and-a-half story Colonial Revival brick building was erected as a private residence and converted shortly after 1920 into a rectory for St. Anne's minister. Finely executed in Flemish bond, the three-bay, side hall/double-pile plan of the house repeats an architectural form that was popularly used in urban areas since the late eighteenth century. The side entrance opens into a hall, which is flanked on the one side by two rooms of nearly equal size. This essential floor plan is repeated on the second and third floors. The Duke of Gloucester Street elevation is particularly well designed with a pedimented entrance surround that frames an arched door opening. Fixed within the arch is a leaded glass fanlight. Large size six-over-six sash windows, which light the first and second floors, are distinguished by carefully executed jack arches with projecting key blocks and end blocks. Also defining the Flemish bond wall is a watertable and beltcourse. Fixed atop the roof are a pair of large gabled dormers fitted with arched windows. The house retains a large portion of its original Colonial Revival interior finishes.

The construction of this dwelling is firmly documented to 1896-97 when Samuel and Julianna D. Jones engaged masons and carpenters to replace the extant structure

on the lot. The 1891 Sanborn Insurance map indicates that a squarish brick structure stood directly along the front edge of the lot. It had been erected since the initial insurance map was issued in 1885. Samuel Jones purchased this property in September 1896 and by the time the revised insurance map had been drawn in 1897 it was standing on the lot. The property had been improved at the time G. M. Hopkins drew his 1878 map of Annapolis for the Anne Arundel County atlas, but by 1885 the lot was clear. Samuel and Julianna Jones resided at this address until 1919-20. In 1919 Samuel Jones was listed in the Annapolis Tax Assessment record with a "37 x 43" lot on Gloucester Street, valued at \$1,035.36 along with a house assessed for \$5,687.11, and furniture at \$100. The following year a notation for this property under Samuel Jones indicated the Gloucester Street house was "exempt" and "sold to church." The house was converted into the St. Anne's rectory following the transfer in 1920.

The former St. Anne's Episcopal Church rectory, now used as part of the St. Anne's Episcopal Church Parish house, is located at 199 Duke of Gloucester Street in the center of Annapolis, Anne Arundel County, Maryland. The two-and-a-half story Flemish bond brick house faces northeast with the roof oriented on a northwest/southeast axis.

Built around 1896-97, the story-and-a-half side hall/double-pile main block is supported by a fully excavated foundation, and it is covered by a slate sheathed gambrel roof. A two-story wing of contemporary age extends to the rear. Mid to late twentieth century additions have been attached to the back of the house and a parish hall addition extends from the north end.

The northeast (main) facade is a two-and-a-half story, three-bay, Colonial Revival elevation with a side entrance and flanking six-over-six sash windows. The front wall is laid in Flemish bond with a beveled watertable defining the foundation, and a stretcher bond beltcourse marks the second floor height. The entrance is highlighted by an elaborate Colonial Revival frontispiece with a full pediment supported on fluted, Ionic, half-round pilasters. The pediment is embellished with beaded bed molding. The doorway has a round arched transom fitted with a leaded fanlight. The double leaf, four-panel doors are framed by a molded surround interrupted by a really key block. The reveals of the entrance opening are finished with a flat panel. The adjacent six-over-six sash windows are of large proportions with elaborate brick jack arches. A center key block of bricks project from the center of the arch along with side blocks. The window itself is framed with a molded surround, and each window is flanked by louvered shutters. Piercing the second floor are three evenly spaced six-over-six sash windows finished in the same fashion as the first floor openings. The top of the wall is boldly detailed with a heavy boxed cornice featuring large blocks. The undersurface of each block is finished in an academic classical fashion with guttae drops. The front slope of the roof is covered with slate, and a pair of large gabled dormers light the attic. The dormers are fitted with founded arch sash windows. Fixed atop the roof ridge is railing with turned posts and rectangular balusters.

The northwest gable end is partially covered by the modern brick parish house addition. The unobscured portion of the wall is laid in Flemish bond with the stretcher bond beltcourse marking the second floor. A six-over-six sash window pierces the upper gable end wall, which is topped with a red sandstone cap. A broad faced pair of chimney stacks rises atop the roofline.

The southeast gable end is four bays across with blind windows on the northeast corner. Laid in Flemish bond as well, the gable end is defined by a projecting watertable and beltcourse. Six-over-six sash windows light the first, second, and third floors. Two cellar windows pierce the foundation wall. The parapet gable end is finished with a red sandstone coping. A pair of brick chimneys pierce the roofline.

The southwest (rear) wall of the main block is largely covered by the two-story flounder wing. The beltcourse of the main block distinguishes the rear wing as well. The first and second floors are lighted by six-over-six sash windows, and the top of the wall is finished with a corbelled cornice. An interior end stack serves the flounder wing. Rising through the southwest wall of the main house is an interior brick chimney, and a large gabled dormer is centered on the rear roof slope.

The interior spaces of the 1896-97 house have remained largely intact. The floor plan follows a modified side hall/double-pile plan. The front door opens into a small, squarish vestibule that flows into the front parlor, which is now used as an office. The projecting chimney breast is distinguished by a Colonial Revival mantel defined by turned columns that rise to acanthus leaf frieze blocks, which in turn support a molded mantel shelf. The mantel frieze is embellished with molded classical motifs. A cast iron insert fills the firebox. Trimming the perimeter of the room is a molded baseboard and cornice.

A modern fire door separates the front vestibule and the main stairhall. Rising in a single flight to the second floor is a turned baluster stair with a large square newel post and a molded handrail. The stringer is plainly finished with a flat edge molding following the stair steps. Enclosed under the staircase is a set of steps that lead to the cellar.

The other first floor room is the back office, which is fitted with a Colonial Revival mantel on the southwest wall. A columned mantelpiece fitted with a mirrored overmantel is fixed against the southwest wall. Fluted Ionic columns stretch from the floor to a plain entablature. The pilasters and entablature frame the fireplace, as well as the mirrored overmantel and mantel shelf. An iron insert fills the firebox, and a wreath decoration embellishes the frieze. Located immediately right of the fireplace is a decorative metal grate that fronts a heating vent.

The second floor is divided in a similar manner with a side passage and two large offices to the east. A small room is partitioned from the stairhall at its north end. This room is simply finished with early twentieth century moldings framing the windows, door, and baseboard. A small closet entered through a four-panel door is fixed between the stairwell and the small front room.

The front bedroom, now used as an office, is dominated by a projecting chimney breast fitted with an early nineteenth century Greek Revival mantel. Detached

7.2 DESCRIPTION

Doric columns rise to a paneled frieze under a stepped mantel shelf. The face of the firebox is covered with decorative tiles, and the openings is fitted with iron fire box panels embellished with a fleur-de-lis motif. A slab of slate serves as the hearth.

The back bedroom, also an office, is finished in a similar fashion with an early nineteenth century mantel attached to the southeast fireplace wall. The late Federal style mantel has pilasters that rise to paneled end blocks. The slightly recessed end block panels have quarter round inside corners. The frieze is plain. A thin, broken line mantel shelf is fixed atop the frieze. The firebox is fitted with an iron insert, and a metal grate is fixed to the right of the mantel. The rooms is also fitted with a molded baseboard and a molded cornice.

The turned baluster stair continues to the third floor with a quarter turn incorporating a landing two steps above the second floor level. The third floor is divided into three rooms with a small room at the head of the third floor hall. The rooms are plainly finished with period moldings framing the doors and windows, and a molded baseboard that trims the perimeter each room. A bracketed mantel shelf is attached to the northwest wall of the small room at the head of the hall.

The cellar is divided into two rooms with a brick bearing wall pierced by two large segmental arched openings.

The interior of the rear wing is less elaborately finished. A projecting chimney stack is pierced by an usually tall fireplace opening fitted with a segmental arch. A glazed door opens through the rear wall. The second floor of the rear wing has been reworked recently with the removal of partition wall to create a large office. The interiors of the mid to late twentieth century additions were not seen.







St. Anne's Parish House is a very fine, academic Colonial Revival structure. Well built, 199 Duke of Gloucester has good Georgian detail. Though the gambrel roof with the double end chimneys could be Federal, the other details such as the Palladian roof dormers with Gothic sash and the rich Palladian doorway with pediment and fluted pilasters are purely Georgian. The Church purchased the building from the Mayor of Annapolis in the early twenties. Though hardly an ancient structure, 199 adds to Duke of Gloucester Street, should be preserved.


