

Capsule Summary of 130-132-134 Main Street (AA-545; AA-547)

Originally constructed on property known as the Market House Lot between 1789 and 1791, the building was constructed by William Wilkins on property leased by Joseph Dowson. Although the building underwent significant alterations at the turn of the century, it stands as a good example of the federal-style domestic/commercial architecture of historic Main Street.

The building at 130-132-134 Main Street was originally two separate two-story brick structures. Between 1897 and 1903 the two buildings were combined into one, five-bay wide building, and the half-story of three dormers was added. The building is located on the northeast side of Main Street at the southeast corner of Hyde Alley. It is constructed of brick, laid in Flemish bond on the front elevation¹ and stuccoed on the remaining elevations. A gable roof with two, paired end chimneys and three dormers covers the building, while a storefront extends across the first story. Although altered from its original appearance, it appears as a well-unified Federal building in overall form, massing and detailing. What appears to be an original two-story ell with a shed roof and brick end chimney projects from the northwestern half of the rear elevation, while a group of later one-story additions abut it. A two-story, detached brick structure, which appears on the 1885 Sanborn Map as a bake house, is appended to the building by a modern hyphen.

The southwest elevation is five-bays wide and features a storefront and side-passage entry. The side-passage entry is located at the far southern end of the elevation. It has a four-panelled wood replacement door and a two-light transom. The wood storefront, set upon a concrete foundation, is contemporary, but in keeping with the late 19th century storefronts of Annapolis. The recessed square entry features double doors, flanked by projecting plateglass show windows and surmounted by a projecting cyma reversa cornice.

The second story of the southwest elevation has five 6/6 windows with original sash, and wood surrounds. The windows are set into the surface of the brick wall and have brick jack-arched lintels. Above the second story rises the gable roof and its three dormers, equally spaced across the elevation. The dormers have 6/6 segmentally-arched windows set within semi-pedimented surrounds. The standing seam metal roof features a row of snow guards above the corbelled brick cornice. The brick end chimney on the southeast end of the roof has been partially dismantled, while the northwest chimney is intact.

The northwest elevation, clad with scored stucco, features windows on the second story of the main building and a single window in the end gable. All the windows feature 6/6 sash with scored jack-arch lintels and wood sills. The paired end chimney is flush with this wall surface and projects above the roofline at the gable ridge. Metal tie rods, affixed to metal beams that are braced against the elevation, extend across the alley between this building and the building on the northwest side of Hyde Alley.

The northeast elevation of the building consists of a series of additions abutting one another. The only exposed section of the main block of the building is its roof, with a single dormer located at the southeast end. The original ell has a single 2/2 window with metal security bars on the second story and a brick end chimney which appears to have lost the majority of its shaft. Abutting the ell is a two-story shed roof addition covered with a sloped roof and clad with vertical board siding. Surrounding this addition and also abutting the rear ell is a one-story, hipped roof addition of concrete block. Both of these additions are from ca. 1930.

The detached outbuilding, formerly a bake house associated with the building when it functioned as a bakery, is a two-story brick structure, laid with six-course American bond brick and covered with a sloped roof, clad with standing seam metal. Concrete parging or repair work is randomly found on all of the brick walls. Two narrow brick end chimneys, one parged and one with replacement brick, protrude above the roofline on the northwest and southeast elevations. The southwest elevation has two infilled openings on the lower story and three boarded up openings on the upper story. The placement of the lower level windows, which abut the foundation, suggests that the existing parking lot area has been built up over the years. The lower openings, filled with brick, have jack-arched brick lintels and appear to have been windows.

The second story openings, covered with vertical boards, appear to have included a central door, flanked by windows. The central door may have opened onto a ramp, as it has a wood sill that has been well worn, as if many-a-foot has trod upon it. This opening also has a wood lintel. The window at the north end similarly has a wood sill and lintel, while the south end has a brick lintel and sill that has been altered. Above the second story windows is a corbelled brick cornice partially obscured by a gutter.

The northwest elevation of the bake house has no visible openings; the additions to the main block of the building also abut the wall of the bake house, obscuring its original wall surface. The building currently is attached on the southeast and southwest elevations.

Based upon a cursory inspection, it appears that the interior of the building at 130-132-134 Main Street has been completely altered on the first floor to accommodate a single retail space; no original materials or details survive. The upper floors, although not surveyed, appear to be used as storage.

When built in the years between 1789 and 1791, the building located at 130-132-134 Main Street was originally two separate brick structures that were combined to create one building between 1897 and 1903. Originally constructed on property known as the Market House Lot, the buildings were constructed by William Wilkins on property leased by Joseph Dowson. Although the building underwent significant alterations at the turn of the century, it stands as a good example of the federal-style domestic/commercial architecture of historic Main Street.

The building at 130-132-134 Main Street is sited on the original Market Square property, which dates from 1728. In 1752 the Market House and lot were sold to Lancelot Jacques, who operated a store on a portion of the lot fronting the dock.² Subdivided by Jacques, the section where the 130-132-134 Main Street is currently located was sold to Joseph Dowson in 1782 for L300.³

Joseph Dowson resided at the site, possibly on the portion of the property later sold to Daniel Wells, while he maintained a store at the site of 130 Main Street. In 1798, Dowson moved to Chestertown, Maryland, leasing the remaining property to William Wilkins. Between the years 1789 and 1791, Wilkins constructed a brick structure on the site.⁴ Although the property generated L45 per annum from Wilkins, Dowson was forced to mortgage it to the firm of Wall, Johnson, and Muir. Dowson defaulted on the mortgage and the sale of the property was advertised in the *Maryland Gazette*:

"...new brick house...40 by 24 feet, fronting on Church and Cross Streets, opposite to Mr. Joseph Clarke, including a brick outbuilding."⁵

The administrators for the Dowson property agreed to sell the building and lot to William Wilkins in 1796; however, Jeremiah Hughes, who repaid the defaulted mortgage, was assigned the rights

to the property.⁶ The Federal Direct Tax of 1798 charged Wilkins with a two-story brick dwelling house, 38 by 22 feet and a one-story brick kitchen, 32 by 18 feet, assessed at \$600.00.

Frederick and Hester Hyde officially owned and occupied the property by 1828.⁷ In 1844, as established in the wills of the Hydes, the property was devised to their five children, Emily, Frederick, Jr., John, Jonathan, and Thomas.⁸ The surviving children maintained the building until 1873, when it was conveyed to Martin Smith.

Martin M. Smith, born in Germany on February 2, 1843, came to the Washington, DC area in 1860. Smith, following his relocation to Annapolis in 1863, operated a bakery and confectionery at 130-132-134 Main Street. In July 1867, he married his brother's widow, Catharina (Peters) Smith, who was born about 1839.⁹ Smith continued to live in the portion of the building known as 130-132 Main Street, while operating a bakery at 134 Main Street. The census records for 1880 and 1900 indicate that Smith lived in the building with his large family and several German boarders who worked in the bakery. Although the building was conveyed in 1920 to Kasper Mayerhofer, it remained a dwelling and bakery.¹⁰ Four years later a default in the mortgage generated the sale of the building to Harry W. Elliott.¹¹

In the late 1920s, the first floor of the building was leased to the American Stores Company, who sold groceries, while the second story was leased to William J. Seely.¹² Upon the death of Elliott in 1942, the property was inherited by his wife, Emma and their

children, who conveyed within three years to Samuel Lerner.¹³ According to the city directory for 1949, the building at 130-132-134 Main Street was leased to the American Stores Company and the Capital Fruit and Produce Company with Emma Friedman, Sarah Henkensiefken, and the Collins residing in the upper floors. The city directory for 1954 states that the building was occupied by Hack's Toys and Games, while carpenter Joseph A. Meiklejohn resided at 132 Main Street.

When Samuel Lerner passed away in 1985, the building was bequeathed to his wife Dorothy, who in turn bequeathed it to Howard, Eugene and Adele Lerner.¹⁴ As current owners, the Lerner heirs lease the building to the Nature Company.





130 Main Street is a slightly later near duplicate of 132-134 Main Street. The first floor is a sympathetic, but altered store front. 2nd floor has five (6/6) windows with wood sills and splayed brick lintels. Above a plain wooden cornice is a metal roof with three (6/6) dormers, triangular with returns. Stylistically and historically these buildings (130,134) are important. They are also important as representatives of "colonial" Annapolis architecture on an otherwise 19th and 20th C. block. 130 Main needs little in the way of restoration.


