

### Capsule Summary of 226-228 Main Street (AA-587)

Built between 1840 and 1877<sup>1</sup>, the building at 226-228 Main Street was constructed just south of Church Circle by members of the prominent Claude family. The building was erected as a residence and was sold, in 1897, by Dr. Abram Claude to the Annapolis Savings Institution, which operated a bank in the building. The construction of the building in this period on formerly undeveloped land provides important insight into the physical development of Main Street.

The 2-1/2-story, three-bay brick building at 228 Main Street is located on the northeast side of Main Street just south of Church Circle and amongst a group of small, two-story buildings. Set upon a brick foundation, the former dwelling is constructed of brick laid in five course bond on the side walls and a random Flemish bond on the front elevation. The Federal-style building is covered with a gable roof, clad with asphalt shingles, and features a central dormer and an end chimney (rebuilt) projecting from the northwest side elevation. A single-bay brick hyphen, designated 226 Main Street and connecting the building with its southern neighbor at 224 Main Street, contains the stair leading to the upper levels, while a two-story rear ell, not visible from public domain, extends towards the rear of the lot line.

<sup>1</sup> The land records from 1855 makes no mention of a building on the site and, although no building can be distinguished on the site on the Sachse Bird's Eye View of Annapolis, the angle of the 1858 print is such that the building could have been there, but obscured from view. Indeed, the building is federal in style with five-course brick side walls, and appears, architecturally, to date from ca. 1840. The building is definitely on the site by 1877, as shown on Grays Map of Annapolis. See the Chain of Title for deed book references.

Built in the mid-19th century, the 2-1/2-story, three-bay brick building at 228 Main Street is located on the northeast side of Main Street just south of Church Circle and amongst a group of small, two-story buildings. Set upon a brick foundation, the former dwelling is constructed of brick laid in five course bond on the side walls and a random Flemish bond on the front elevation. The Federal-style building is covered with a gable roof, clad with asphalt shingles, and features a central dormer and an end chimney (rebuilt) projecting from the northwest side elevation. A single-bay brick hyphen, designated 226 Main Street and connecting the building with its southern neighbor at 224 Main Street, contains the stair leading to the upper levels, while a two-story rear ell, not visible from public domain, extends towards the rear of the lot line.

The front elevation of the original building (228) consists of a storefront on the first story, three bays of windows on the second story and a central dormer window at the attic level. The storefront is articulated by a 15-light projecting show window set upon a brick foundation and a single-light, cross-panel door which leads directly into the first floor retail/commercial space. Above the door and show windows is a projecting wood frieze board bearing the name of the store which recently occupied the first floor. A shed roof clad with standing seam metal projects from the facade of the building.

Built against the southeastern elevation of the original building and connecting it to 224 next door, is the stair hyphen, designated 226 Main Street. The hyphen consists, on the exterior, of a single door opening on the first story and an unornamented brick wall above. The entry door of the hyphen, which leads directly to a straight-flight stair providing access to the offices on the upper floor, has a replacement door with six lights in the upper portion of the plain wood door.

The second story has three symmetrically spaced, original 6/6 windows with wood sills and brick jack-arched lintels. Above the second floor rises the gable roof supported by a boxed cornice. A central gable dormer with a 6/6 replacement window adorns the wide roof surface. Like the roof of the building, the sides of the dormer are clad with asbestos shingles.

The interior and rear of the building were not accessible and were not surveyed.

Built between 1840 and 1877<sup>1</sup>, the building at 226-228 Main Street was constructed just south of Church Circle by members of the prominent Claude family. The building was erected as a residence and was sold, in 1897, by Dr. Abram Claude to the Annapolis Savings Institution, which operated a bank in the building. The construction of the building in this period on formerly undeveloped land provides important insight into the physical development of Main Street.

The land on which 226-228 Main Street is located originally occupied a portion of the large triangular lot of ground designated Lot 73 on the Stoddert Map of 1718. By the mid-18th century, this large lot of land was divided into several parcels, owned by various individuals. Based upon the property lines, it appears that the property on which 226-228 Main Street now stands fell within two separate parcels.<sup>2</sup> Additionally this portion of the property included the northern parcel now occupied by 234 Main Street, while the southern parcel included the property now occupied by 226-228 Main Street. From 1765 to 1780, both of these parcels were owned by Nathan Waters. In 1790, Waters sold part of his property (the southern portion) to his granddaughter, Elizabeth Chisholm, who had married Archibald Chisholm. In 1787, Archibald Chisholm again divided the property by selling a 27-foot frontage of the property on School Street. In 1798, Chisholm was charged with one, single-story frame dwelling house and a brick kitchen, in bad repair. Neither of these buildings survive today.

Between the years 1799 and 1809, the ownership rights to the property were being examined in the General Courts, because of a petition submitted by Benjamin Harrison. The courts ordered the property be sold to the highest bidder at a public sale. In 1811 the property was conveyed to William Marriott. Marriott sold the property consisting of a house and lot within four years to Major

Samuel Maynard.

By 1833, Dr. Dennis Claude purchased the property in its entirety from Samuel Maynard.<sup>3</sup> In 1855, Ann Claude obtained a portion of the property, without buildings on it<sup>4</sup>, as part of an equity proceeding. This portion of land corresponds with the two parcels currently occupied by the buildings at 224 and 226-228 Main Street. By 1871, Anne Claude had died and the property was transferred to her son, Abram Claude, Jr.<sup>5</sup> The deed transferring the property mentions a two-story brick house on the site. The description of the deed reads, "beginning...at the southwest corner of the two-story brick house standing on said lot," indicating that the building at 224 Main Street, which is at the southern end of the property, was built between 1858 and 1871. It does not, however, preclude the existence of 226-228, which appears, in fact to be from ca. 1840. In any case, the building is definitely on the site by 1877, as it appears on Gray's Map of Annapolis.

The property remained intact until 1885, when Abram Claude divided it into two and sold the parcel on which 220-224 Main Street stands. Abram Claude held onto 226-228 Main Street until 1896 when he sold it to Annapolis Savings Institution. Although no deed records the transaction, it appears that Abram Claude had already been leasing the building to the bank as it appears on the 1885 and 1891 Sanborn Maps as a bank. In 1897, the building is still shown simply as a bank; by 1903 it is marked as Annapolis Savings Bank.

In 1905, the bank sold the building to James Edward Abbott and in 1908, James Edward Abbott sold it to Roy N. and Elizabeth H. Tydings. In 1908, the building is shown as being vacant on the Sanborn Maps and in 1913 it is listed as an ice cream store. In 1919, the Tydings sold the building to Morris and Fannie Sheff and

<sup>5</sup> Abram Claude (born 1818), was a physician by profession, and served as Mayor of Annapolis from 1847-1850, 1854, 1867-1868, and 1883-1889. During the years 1871 and 1883 he was a professor of natural sciences at St. John's College. Between 1895 and 1899, Abram Claude was postmaster.

in 1921 the building is shown as a cobbler shop. An historic photograph from this period confirms the building's use; it shows the building with a sign, C.A. Brady Boots and Shoes across it.

The property remained in the Sheff family until 1964. The building at 226-228 Main Street is currently owned by Ronald B. Hollander and was undergoing renovation at the time of the survey in May 1994.






Tax Map of Annapolis, Maryland
