The Shief House is a summer cottage located in the incorporated private, community of Highland Beach. It is a large, two and one half storey structure built for a prominent black family. It is a fine example of the architectural preferences of descendants of people who were influenced by slavery and an African and European dialectic.

The house is a substantial element in the design of the Highland Beach resort community and exists as a preamble or harbinger of the quality of design in the rest of the community. It serves significantly as a socio-spatial element in the town and its position at the entrance to the community complements the unconscious design of the town.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Shief Cottage is a large gambrel roof structure standing two and one-half storeys. It has recessed dormers on the second storey gable end and an exposed chimney. The roof over the porch is supported by Tuscon columns. The first floor is encircled with a screened porch. The cottage is quite imposing as one enters Highland Beach and may be one of the land mark structures in the settlement.

The frame house was constructed in the first quarter of the twentieth century and the New England gambrel roof design is repeated on the small storage building in the rear of the lot.

The Shief Cottage is located at the intersection of Douglass Avenue and Walnut Avenue in Highland Beach. Its site is the southwest corner of the intersection and borders the corporate limits of the town separating the settlement from Venice Beach. Lying approximately ten miles south of Annapolis, the site is also surrounded by Oyster Creek in the south, the Chesapeake Bay towards the eastern extremity and Black Walnut Creek towards the northeast. The topography slopes towards the creeks and the Chesapeake Bay and it has dense vegetation on both the developed and undeveloped lots.

This two and a half storey cottage is a dwelling with a rectangular plan. The low stone foundation is composed uncoursed fieldstone on rubble. The norths elevation faces Douglass Avenue. The principal facade is three bays wide and is composed of beveled, wood siding. The enclosed porch which compliments this view is constructed of a twelve bay screened facade supported by wood posts. The three bay entrance porch is one storey in height. The Tuscon order columns support the shed roof which extends the length of the porch.

On the second storey of the north elevation, three dormers are recessed into the curved side of the roof. One central dormer is three bays wide and is shielded by a hip roof. Symmetrically balancing the central dormer are two single bay, dormers with hipped roofs. The shingle siding on the dormers, the curve of the gamarel roof and the hip roofs is a diamond shaped imbricated pattern. The windows are sash type six lights over a single pane with white, wooden surrounds.

The east elevation is bordered by an eight bay screened porch although the principal facade is only two bays wide. This view exhibits an outside end, block chimney. The chimney is constructed of a red brick with a running band. The beveled wood siding is exposed on the first, second, and half storey. Windows are symmetrically situated, flanking the narrow chimney.

STATEMENT OF SIGNIFICANCE

(see "Highland Beach Settlement")

The actual date of the construction of the shief house is not known. Many of the houses in Highland Beach were constructed by the owners and their children over several years. The Anne Arundel County Building Permits Division does not have record of improvements to real estate that were done in this part of the county prior to 1963.

The Shief property chains back to the Will of Charles R. Douglass and is one of the properties that was owned by Haley G. Douglass. This cottage is one of several properties that were originally designed by prominent African-Americans in the community. It's primary significance rests within its value as a structure that is located in the plan of the town of Highland Beach. Structurally it is a functional example of high-style twentieth century architecture and symbolizes an expression of prominence and power in an era of Jim Crow legislation segregationist policy and black self-consciousness.


