The Wyatt House is a frame, Dutch gambrel roof cottage in Highland Beach. It is one of several significant extant examples of architecture designed for black Americans. The house was designed to be the summer home of a prominent black doctor, Dr. Milton Francis, and his family in the early quarter of the nineteenth century.

The Wyatt House departs from the traditional design schemes that have been established in the community. However, it also exhibits some architectural elements that are compatible with similar structures in the area. Its position in the community and its form are integral components of the analysis of this town and its uniqueness in black American history.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Wyatt House is a one and one half story bungalow with a Dutch gambrel style roof. It is a wood frame dwelling and is one of the few houses in Highland Beach that has a basement. The shingle siding is painted an earth tone with mahogany colored trim. The house was probably constructed around 1920 although the exact date is not known.

The Wyatt House is located at 1336 Bay Avenue in Highland Beach. It is situated in the block that is bounded by Black Walnut Creek marsh on the north, the Chesapeake Bay on the east, Bay Avenue towards the south and Bruce Avenue in the West. The land which surrounds the lot is marshy and sandy. Vegetation is a little less dense than in other lots in the area. The lot slopes considerably into the marsh near a tributary of Black Walnut Creek that flows into the Chesapeake Bay.

The house rests on a low stone foundation in the rear and the basement of the structure is constructed above grade. The front or southern view exhibits an enclosed porch which rests upon a pier foundation constructed of rock faced stones. Decorative cement blocks have been placed in the spaces between the piers. A stone retaining wall borders a portion of the lot on this view.

The southern view porch is enclosed with screening and a wooden railing borders the screen. A shed roof covers the porch and two dormans are recessed into the slope of the gambrel roof. The windows in the dormans are sash type with six panes in each section. The roofs are finished with asphalt shingles. On the eastern view of the house, the windows are also sash type with nine panes in each section on the first floor and six panes on the upper story.

The northern view, facing Black Walnut Creek has a veranda on the level above the basement. This porch is also screened and is supported by wooden posts and beams. The western view exhibits an interesting entrance, possibly to a garage or storage area. The doorway is shaped like a mock gambrel roof with wooden trim surrounding it.

STATEMENT OF SIGNIFICANCE

Highland Beach, Maryland is a historic black town that was founded by the son of Frederick Douglass. The town was conceived by Major Haley R. Douglass to be a resort community for prominent blacks in the late nineteenth century. Highland Beach is a unique, existing reminder of town planning and architectural history as it relates to vernacular and high style design exhibited by black people. Most of the architecture in Highland Beach is located on the original sites and building expansions were performed within a ten to fifteen year time frame. This provides us with a concise history of design, space planning and architecture in a homogeneous, extant community.

The Wyatt House was owned by Dr. Milton Francis who was the son of Dr. John Francis, both prominent urologists in the Washington, D.C. community. The Francis were also leaders in the Highland Beach community and many of the policies affecting real estate development in the town were defined by them. This house is considerably unlike the primary stick style and white cottage affect of most of the houses in the town. Its characteristics which exhibit the Dutch gambrel and an extension of the bungalow styles is unique in this community. All of the houses in Highland Beach are significant with respect to this district, and the Wyatt House needs to be further evaluated especially as it contributes to the development of alternative building patterns at this time.




