The Holland House is a large cottage with an awning overhanging an extensive porch that encircles three views. The front facade is deceiving because it shields the massiveness of this house which consumes almost one third of the lot. The house is located in the historically black town of Highland Beach and is an example of the quality of architectural design and construction that was evident in this community.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Holland House is a large, two storey cottage with gable roof. The house has several additions and extensions that are cantilevered to the main house which results in a clustered effect for the dwelling. The house has a basement and an enclosed porch which encircles three views.

Highland Beach is a summer beach community that is about ten miles south of Annapolis on the Chesapeake Bay. The Holland house is located on a block which is bounded by Bay Avenue on the north, Langston Avenue to the east, Douglass Avenue on the south and Bruce Avenue on the west. The topography of the lot slopes steeply towards the Chesapeake Bay and supports vegetation which creates a wooded environment.

The cottage is supported by a cement block foundation which corresponds to the slope of the lot creating an above grade basement under the main wings of the house. The rear porch is supported by posts which extend the height of the rear cellar. The southern view of the house is the front of the house and exhibits a low foundation which supports an enclosed porch. The front porch is enclosed with a partial wooden wall and screening. The door has one rectangle and four squares placed in a geometric pattern between two sets of rectangular side lights. The gable of the second storey roof is attached with the porch and exhibits a double hung window on the facade. Window awnings and porch awnings are constructed of aluminum and are utilized on the southern and western views.

An exterior chimney can be observed on the eastern view. Windows are double hung with multiple lights over a single pane. Finishing materials on the exterior consists of novelty siding and a brick bond shingle pattern on the roof.


