DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>This simple, brick house is marked on the 1860 and 1878 county maps. Its respective owners were H. H. Thomas and C. Pumphrey. The house has since been owned by members of the Linthicum family.</p> <p>The house consists of two 2-story brick sections and several small frame additions. The front section of the house faces east, and the other section forms a wing on its west side. The two chimneys on the house are an unusual feature. They rise on the west side of the front section, parallel to the side walls rather than the end walls which is the normal orientation in houses of this style. The only other known example of this variation is found at the Patapsco Bridge Toll-house (#113 on the survey). The Thomas House and the Toll-house are within a mile of each other and were both built in the second quarter of the 19th century.</p> <p>The front section of the Thomas House has five openings on each floor with the entrance in the center opening. All of the windows in this section have flat brick arches except the window at the north end of the east facade on the first floor level. It has a segmental arch like those in the back section of the house. The first floor windows on the east elevation have 9/6 pane sashes; all of the others have 6/6 pane sashes.</p> <p>There is a small, open porch on the east elevation. It has a hip roof and turned wooden columns with scroll-cut brackets.</p> <p>The east and west walls of the front section of the house have a dentilled brick cornice.</p> <p>The frame sections of the house appear to be recent (20th century) additions.</p> <p>There is a small brick building located to the north-west of the house. It retains very little of its original appearance because it has been covered with aluminum siding.</p>
