**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Luther Shipley house is situated on 33.97 acres of land, bounded by Andover Rd. on the south, Andover Rd. on the east, Fairmont Ave (a dirt road ) on the south and another dirt road on the west. The preferred entrance is off of Fairmont Ave.

The Luther Shipley house is a 2 story frame t-shaped dwelling, five bays wide and two bays deep. Built in 1888 in the Gothic Revival Style and covered with German siding, it replaces an earlier dwelling which burned.

The front elevation faces east. An above grade porch, having a shed roof porch supported by chamfered posts and flat jigsaw brackets extends across it. The porch is screened in all but the fifth bay. The second story center bay , covered with asphalt shingles, projects from the facade.

The main entrance is located in the center bay of the front elevation. The door, painted and grained to resemble mahogany, has 6 deeply molded panels, the top ones arched. An embossed metal knob and key hole are still present. All of the exterior and interior doors display painted graining in very good condition simulating several different kinds of wood.

Most of the windows have 2/2 lights with wide board enframements, having slightly pedimented enframements, and shutters. Those on the first floor are taller than those on the second. A segmental arched window is in the 3rd story, north elevation , and a three sided bay with 1/1 light sash projects from the south elevation.

Off the kitchen , at the southwest corner of the dwelling, is a four bay porch with a shed roof supported by chamfered posts and lacy jigsaw brackets.

The Gable flank roof is covered with asphalt shingles and has two center chimneys. The eaves overhang slightly and are boxed. The roof on the wing is similar with a chimney on the west end.

Interior: The first floor has a center hall plan with . stairs on the west wall and a room on either side, parlor and dinning room. Both rooms have fireplaces on the inner or hall wall. The north room has a marbelized slate mantel while the south room has a plain wooder mantel. Latrobe stoves were removed from both of them. In addition, the two front rooms have painted wood grain woodwork (some of which has been painted white), plaster ceiling medallions
