Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This tenant house at Creekside Farm was probably built c.1906-10 by Mr. James Murray, owner of Creekside Farm. Apparently the house was constructed initially as a one-room-up, one-room-down frame dwelling much like its farm neighbor "Jane's House" (AA-905). The original 1906-10 portion is today the left half of the present side-gabled main block.

Within a few years of construction of the first portion, the second portion, or right half of the main block, was added, doubling the size of the original structure.

In 1912-13 a separate one-room-up one-room-down structure, located four feet behind the left half of the main block, was added. (The 4-foot in-between space was later in-filled with a bathroom.) James Wells Jr. (born c.1905) remembers that the separate rear section was built by a carpenter Mr. Glover from Galesville to accomodate the arrival of the large Wells family to Creekside Farm. James Wells Sr. worked as a tenant farmer for Mr. James Murray until c. 1925.

In 1925 Mr. Murray's wife Susie died, and their son Churchill married Marjorie Burwell from Lothian.¹ Wilson Parker, tenant farmer, parttime preacher, and friend of Marjorie's from Lothian, moved into the Creekside Farm Tenant House. He soon married Louisa Brent, a native of Cumberstone, born 1895. [During the early 1900's "Miss Susie" Murray used to conduct Sunday School at Cedar Park for the Cumberstone black children. Louisa Brent attended this school as recounted by her daughter Jessie Neal, current occupant of Parkhurst Tenant House (AA-907) across the road from Creekside Farm.] Wilson Parker lived in Creekside Tenant House until 1943 (Louisa died in 1941).

From c.1945-1955 Creekside Farm Tenant House was occupied by the Hartges, a white tenant family.

In 1956 the current occupants moved in, Joseph and Bernice Tongue. Joseph, a Cumberstone native, was born across the road at Parkhurst Tenant House in 1937; his mother's aunt was former Creekside occupant Louisa Brent Parker. Bernice comes from Lothian, and her father's uncle was former occupant Wilson Parker. Small world!

For generations in Cumberstone a few black families have shared among themselves the available farm jobs and tenant houses, while the land has remained in the hands of the Murray family. During years of living side by side, the land owners and employees developed a relationship of mutual need and familiarity. Black women nursed white children, and white women schooled black children. Sue Murray recalled

her mother Marjorie carrying dinners over to an ailing Wilson Parker at Creekside Tenant House after his wife had died.

But in the 1960's demographic changes came to Cumberstone when the Smithsonian began to acquire land there: in 1966, Ivy Neck farmland, in 1970 Parkhurst farmland, and in 1980 Poplar Knowle farmland, all sold to the Smithsonian in an effort to protect the land from development. This transfer meant the end of the symbiotic relationship between white families and black families in Cumberstone.

The new owner, the Smithsonian Environmental Research Center (SERC), continues many of the same farming activities on the land, but the labor force is hired from outside, and local black families have moved away. The tenant houses are mostly empty and deteriorating. (See AA-225A and AA-225D at Ivy Neck.) One family, Sam and Jessie Neal, was given a life estate in their tenant house (AA-907 Parkhurst). Sam died in 1986. When Jessie leaves, her house will no doubt remain empty too.

Creekside Farm Tenant House, which does not belong to the Smithsonian but is still owned by the Murray family, is about the last house in Cumberstone to be occupied by native Cumberstone blacks.
