Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Poplar Knowle Farm Tenant House #1, built c. 1906, is a modest 2-story, 3-bay, one-room-deep frame dwelling with a side-gabled roof. The wall structure is transitional: partly post-and-beam and partly balloon style. It rests on ten brick piers spaced evenly under the perimeter.

Commercially available building materials were used in the construction, specifically: vertical board-and-batten exterior siding (which was generally less expensive than horizontal weatherboarding), raised-seam tin roofing, and interior vertical beaded paneling typically found in turn-of-the-century housing.

There is a narrow brick chimney in the center of the building with flue openings in each west-end room, upstairs and down. There are two rooms downstairs, and two rooms and a landing hall upstairs. An enclosed stairway hugs the inside ~~east~~ corner of the building, with a built-in closet below the stair and another above.

There is no plumbing in the house. A two-seat outhouse is located at the west side of the yard. There is also a small outbuilding behind the house, to the south. Its gray board-and-batten siding and tin roof match those of the house.

Prepare both a summary paragraph of significance and a general statement of history and support.

In 1877 Henry Murray bought Tulip Hill Farm with its magnificent Georgian manor house dating from 1752. In 1906 Henry's widow sold the house and 54 acres, saving 150 acres of land for her son Robert. Robert immediately began improving his property which he named Poplar Knowle. He built a large frame residence (AA-237), also five barns and at least three tenant houses (one has disappeared since 1970 when the most recent USGS map of the Deale Quadrangle was prepared). Poplar Knowle Farm Tenant House #1 was one of these three built by Robert Murray circa 1906. It is the only board-and-batten style building in the Galesville-Cumberstone Black History Survey Area.

Robert Murray died before 1934 and his wife died in the 1950's. The main Poplar Knowle residence stood empty for about 20 years until 1980 when the Smithsonian Institution purchased part of the estate of Robert's son Henry for its Rhode River Environmental Research Center. Included in the acquisition were Robert's 1906 residence and Poplar Knowle Tenant House #1. (Tenant House #2, on a separate 15-acre parcel south of Tulip Hill, was purchased by Eric Steinlein.)

The last black family to occupy Poplar Knowle Farm Tenant House #1, circa 1977, was that of Arthur "Fatback" Tasker and his wife Viola, and sons "Junebug", Henry, and Charles. The house was empty from 1977 until 1986.

In 1986 the Smithsonian sold 9.2 acres of Poplar Knowle Farm land, including Tenant House #1, for residential development. A new residence is being constructed on the property. According to their architect Robert Hammond, the owners plan to restore the exterior of Tenant House #1 and adapt the interior as a private dance studio.



