Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

With features from the Georgian Revival style of architecture, the Psychology Building is a common bond brick building that rises two and a half stories in height. Located northwest of "C" Building, the Psychology Building faces north. The main block of the building measures five bays wide and is flanked on each side by a smaller two story, one bay wing. The building is five bays deep and has a gable roof.

A molded brick water table appears just above grade. The fenestration pattern consists of 9/9 sash windows, concrete sills, and brick jack arch lintels. A brick string course divides the first and second floors. The wall culminates in a boxed cornice. Two flush wall chimneys frame the five bay section. The triple flue chimneys interrupt the peak of the gable and display corbelled rims. The main block also exhibits a pedimented pavilion which incorporates the three central bays. The pediment gable has a simple wooden boxed cornice. The face of the gable is decorated by an oculus window with concrete keystones at the quarter marks.

The outside bays differ slightly from the rest of the building. In addition to only rising two stories, the second floor of the wings are constructed of wooden panels and pilasters. A concrete string course provides the transition between the brick and the wood. The second floors have their own slate covered gable roofs. The pediment gable appears on the east and west face of each respective wing. Boxed cornices and plain soffits detail the gables.

Because of the topography, the Psychology Building has a one-story wing off the south wall at ground level. The wing is five bays wide and nine bays deep with a flat roof and mental cornice.

Built in 1942 as the Admissions Building, the Psychology Building was a component of a plan to expand the hospital to the northwest of the original complex. Though not quite fifty years old, the building displays a degree of ornamentation which contributes to the architectural setting of Crownsville Hospital Center. The Georgian Revival features such as the gable roof, pedimented pavilion, flush wall chimneys provide the building with architectural integrity. The workmanship, materials and the massing have been retained and still convey the essentials of the design.
