This property is a mid-nineteenth century residential building constructed of coursed rubble stone. It has a five-bay, double pile plan with a symmetrical front elevation. A one-story hip roofed porch runs across the full width of the first floor of the front elevation. The building is topped with a longitudinal gable roof that sports a large, central perpendicular gable flanked by smaller gabled dormers.

On the first floor, a pair of transomed french windows open on to the porch in both bays to either side of the central front door, while the second floor has (two-over-two double-hung?) sash which appear to be intact behind plywood covers. The porch retains all of its mass produced jig-sawn railing and brackets although two bays of the porch have




On the interior, the plan appears to remain largely intact as does much of the interior trim and finishes, including several early twentieth century lighting fixtures.


