This building located near the corner of Guilford and E. Biddle Streets is two stories high, four bays wide, has a flat roof and dates from the mid to late 1800's. The brick exterior, laid in running bond, is accented by flat brick and stone sills, arched brick lintels, brick belt courses and a cornice which runs the width of the building over the first floor and indicates an alteration to the original structure. This building was in all probability an old carriage house or garage for surrounding property owners.




