DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story double, semi-detached, related, U-shaped residence formed by the two, three story bays of the main facade. The window design used throughout the bay is a three sash with mullion and transom construction with a slipsill and moulding separating the main window and the transom. Each bay has a boxed cornice with projecting eaves.

The roof cornice which surrounds the entire structure is a boxed and bracketed one, with an undecorated frieze.


