DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The tri-level, shingled structure is irregular in plan. The two story gabled section, which is considered to be the center of the building, has a two story bay with boxed cornice at the gabled side. Windows are only in the second story of the bay and are plain trim, double hung, 1/1.

The one-and-a-half story boxed section at the left is covered by a mansard roof with plain boxed cornice. Gabled dormers with overhang and triangular, double hung, 6/6 windows complete the design. The single story asbesto tile section which faces East 32nd is presently used as a hardware warehouse and may have been added later.

The oversize-gable dormers, two story bay, mansard roof and general application of additive design are commonly used in other Waverly homes. The structure's design, eclectic in nature, carries the same "disproportionate" scale of so many homes within the area.





Sanborn Map, 1915, Volume 7, Sheet 718





Sanborn Map, 1928 (Reprinted 1953), Volume 7, Sheet 735
