DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story shingled offset gabled building has notably a second story oriel and gabled dormer with slight overhang. The oriel contains a double hung, Queen Anne window in the side sections and two in the front. The gabled dormer has a plain boxed cornice with projecting eaves and a Victorian clover design window with plain trim surround.

The main entrance is a single leaf door with wrought ironwork covering the windowed section. A flat roof with plain boxed cornice provides the covering for an enclosed first story with a front window construction of five sash with mullion and two sash with mullion for the side.

STATEMENT OF SIGNIFICANCE

The building once was the residence of Louis Aull, who, along with his brother Jacob Aull, were the builders of most of the cottages in the early history of Waverly. This building is typical of the architecture in Waverly, both for single detached and double semi-detached homes.



