**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This intermediate-block common bond brick rowhouse is 2 stories high, 2 bays wide on the 1st floor and 1 bay wide on the 2nd. A slate shingle pent roof covers the projected right entrance with a round-headed door and the right grouping of 4 double casement windows with metal sashes, brick sills and lintels.

A high front gable, joined on the right by the 2nd floor gable of its neighbor, holds an identical window grouping. A small opening in the upper gable allows for ventilation. The steeply pitched primary roof is also shingled with slate.




