DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two bay wide, three story house is built of brick laid in running bond. It was not built as <sup>one</sup> of a row of houses, but was built individually in a row of individually built houses.

A small, boarded, rectangular wall opening remains to the right of the two-step wooden stoop. The rectangular entranceway is filled with a plain wooden door surmounted by a two light rectangular transom. The doorway, which is on the right, has a wooden sill and flat brick lintel. The first floor window is double hung with 4/4 lights, as are all of the windows. All have wooden sills. First and second floor windows have flat brick lintels. Third floor windows have shallow pedimental lintels of wood.

A simple brick cornice runs at the line of the low gabled roof.

## STATEMENT OF SIGNIFICANCE

One of the few early Sharp-Leadenhall houses with any stylistic pretension at all, a pair of flattened pedimental lintels are set above the third floor windows. The original, square paned, 4/4 light windows remain in the front of the house.





