The majority of the three story high, two and three bay wide brick houses along this side of Montgomery St. were built by Samuel Bratt between 1853 and 1871 for the rising number of middle class residents in the area. The group of houses extending from 206-218 E. Montgomery St. were originally all built with gable roofs but a number have had their rooflines remodeled to resemble shed roofs with simple bracketed cornices. The group of houses built by Bratt between 220 and 240 E. Montgomery St. were built after the Civil War in the currently fashionable Italianate style, with shed roofs and bracketed cornices. The large three story, three bay wide brick house with shed roof and simple modillion cornice at 200 E. Montgomery St. was built in 1848 (with a gable roof) by John Watchman, partner of Bratt in the firm of Watchman and Bratt, steam engine manufacturers, whose business was located to the rear of these properties along Hughes St. At 202-204 E. Montgomery St. is a pair of two story, two bay wide brick houses with shed roofs and bracketed cornice, built in the 1870's

 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three story brick house with gable roof is the last of the original group of four such houses that were the first three story houses built along this side of Montgomery St.

The house is three stories in height, 16' wide, and occupies a 75' deep lot. There is a two story tall, two and one half bay deep rear addition. The house is constructed in running bond. The low-pitched gable roof has a two-tiered, simple brick cornice. There is a double hooded chimney along the east end wall of both the front and rear gables.

All of the window openings have deep, flat wood lintels and sills. The window openings of the first floor are filled with 6/9 lights; those of the second and third floors are filled with 6/6 lights. The modern six panel door is set slightly back beneath a single light transom with a segmentally arched brick lintel, the glass of the transom curved to fit the arch. The house sits on a low basement, the entrance being reached by two marble steps. A square coal opening with a flat wood lintel is located to the right of the steps.





