DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story gable roofed brick house is one of the tiny alley houses that once served as homes for the servants of the more well-to-do inhabitants of Montgomery and William streets.

The house is two stories in height, about 12' wide, and occupies a lot 50' deep. The main house is two rooms deep and there is a one story, one bay deep frame addition. The house is constructed in running bond. The steeply pitched gable roof is covered with asphalt shingles. Both front and rear gables have dormer windows. A double rectangular chimney is located along the western side of both the front and rear gables. A two-tiered brick cornice runs across the facade.

The door and window openings have flat wood lintels and sills. The first floor window is filled with 2/2 sash, the second floor windows with 1/1 sash, and the dormer windows with 6/6 sash. A modern six panel door is set beneath a four-light transom. The house sits on a low basement, the entrance being reached by two stone steps. There is a rectangular coal opening located to the right of the steps, under a flat wood lintel.

STATEMENT OF SIGNIFICANCE

See under 123-125 Churchill St.

This house, and the several adjoining 2 1/2 story houses along this side of Churchill St., seems to have been built by John Berry, who built the corresponding larger houses along Warren Ave., on the rear of whose lots these houses were built. This particular house was built on the rear lot of 110 Warren Ave., a three story, gable-roofed house built by Berry in 1841. Like most of its neighbors, the house has recently been restored into an attractive dwelling.
